WETNET LESSONS LEARNT



WETNET has tackled the issue of implementing multilevel governance for MED wetlands in order to improve their ecosystems and surrounding local systems.

The project aimed at ensuring higher coordination between different levels of spatial planning and the stakeholders involved in site management, while limiting conflicts between conservation issues and economic activities.

WETNET LESSONS LEARNT: WETLAND CONTRACTS

WETNET promoted the Wetland Contract, which took different forms and designations to be adapted to the local contexts and regulations in each of the participant countries, being defined as an agreement between public and private parties, implying real commitments by the signatories.

There were 9 Wetland Contracts promoted as governance plans, with the following specifications:

Italy: The regulatory framework is advanced and well defined even if not quite homogeneous in all Italian regions.

Spain: Environmental Agreements (with an attached Action plan), in agreement with the Water Framework Directive.

Portugal: Innovative tool to be developed in the framework of the "negotiated environmental agreements" mentioned in Annex VI of the Water Framework Directive (Directive 2000/60/EC of 23 October 2000).

Slovenia: Simplified to Memorandum on participation in wetlands conservation of Ljubljansko barje Nature park.

France: The regulatory framework on River/Wetland Contracts is advanced and well defined.

Malta: The Memorandum of Collaboration is the first step, of many necessary, towards a Wetlands Contract for the island of Gozo.

Wetland Contracts include an Action Plan, its implementation being a critical factor. They take into account the resources necessary for implementing the action plans, but the wetland contracts in the pilot sites have not guaranteed all of the financial commitments by the signing parties.

ACTIONS

 Defining territorial planning tools and legal regulations;

- Protecting biodiversity and water quality and quantity;
 Restoring habitats and
- wetland natural dynamics; - Developing green infrastruc-
- tures;
- Developing territorial branding and marketing;
 - Promoting sustainable tourism (year-round tourism, providing new infrastructures,...);
- Promoting joint monitoring (database, water quality);
- Environmental education;
- Sustainable development

(economic activities, farming, eco innovation).

STAKEHOLDERS involved in the process are:

Public bodies: Municipalities, Environmental agencies, Ministries or national departments and regional authorities competent on rural development, agriculture, livestock, environment, infrastructure, territorial planning, cultural heritage and research centres/universities.

Private entities: land

reclamation/irrigation consortiums, farmers' associations, sectorial associations, Local Action Groups for rural development, tourism institutes, environmental associations.

DIFFICULTIES FOUND:

• The methodology used for developing the processes and the Wetland Contract must be adapted to each specific site. It is essential to take into account the heterogeneity of the actors and the multiplicity of positions linked to the territorial complexity.

- Difficulty engaging the appropriate stakeholders.
- Public bodies have some troubles in taking on new financial commitments related to the action plan.
- Need to provide adequate communication documents to increase the understanding and acceptance of Wetland Contracts.
- Long duration of the process.
